Item # 10, Noah and Mila Landa stated to the Commission they wanted only to put up a privacy fence on the property which is in question on this item #10. Mayor Perry replied that our attorney is still working with a title search company and no determination has yet been made. With no other updates or information to discuss this item required no action.

No action was taken regarding the insurance coverage of the Gorman Food Bank. Tacy received two emails from TML stating what all the requirements would be for adding this service as a Non-Profit location to the city's liability insurance.

Vicki Perry presented an amended copy of the bylaws of the Charlie Garrett Memorial Library board. Commissioner Miears made the motion to accept the amendments made to the bylaws with a second from Commissioner Straw. Motion carried 3-1.
